# Potential Legislation – Scientific Advisory Committee

---

## § 9.1-1112. Meetings and chairman.

The Committee shall meet twice a year in the City of Richmond and at such other times and places as it determines or as directed by the Governor or the Forensic Science Board. A chairman shall be elected from among the members appointed by the Governor. Staff to the Committee shall be provided by the Department of Forensic Science.

- Remove designated meeting location to allow meetings at the new Central Laboratory in Hanover County

- Ethylbromazolam





# Case Transfers and Outsourcing

---

- Internal case transfers are continuing
  - Firearms (majority from Western)
  - Latent Prints (from Northern)
- Outsourcing
  - Non-persons cases for DNA testing – Bode Technology, Lorton, Virginia
  - OCME Toxicology cases (from Western only)
  - Controlled Substances – THC edibles only – NMS Laboratories, Willow Creek, PA



# Western Firearms Review

---

- Firearms comparisons were halted in April 2025
- Firearms comparisons are not on the Scope of Accreditation for the Western Laboratory
- Corrective Action resulting from proficiency test
- Case reviews by external provider

# National Association of Forensic Science Boards

---



- Type 1 member representing the FSB to the NAFSB
- Attended 3rd annual NAFSB Conference - University of New Haven, Connecticut, October 20-21, 2025
- Key takeaways
  - Different states have different structures for oversight
  - Received legal and federal funding updates
  - Heard presentations on newer technologies

- All disciplines had a decrease in submissions for CY 2025
- There were both increases and decreases in the ending backlogs
- All disciplines, except Toxicology, had an increase in average TAT (turnaround times)

# Staffing and Budget

---

- Maximum Employment Limit: 369 (342 GF + 27 NGF)
- Current Staffing: 329 GF + 19 NGF (all GF positions are in-recruit)
- ~\$5,453,000 remained at the end of FY2025
- DFS approved to carryforward \$5,452,192 for the following purposes:
  - \$3,299,455 for the purchase of replacement Breath Alcohol equipment
  - \$2,152,737 to cover transition costs for the new Central Lab

# Governor's Introduced Budget

## Introduced Budget Non-Technical Changes

### **Increase staffing for the Forensic Biology Section (DNA)**

Provides funding and two forensic scientist positions to address workload issues in the Forensic Biology Section. These positions routinely examine items of evidence for the presence of biological material and are qualified to perform the full range of testing provided by the section.




# Compensation Study Conclusions: Forensic Examiners and Evidence Receiving

---

- All Forensic Examiner-type minimum salaries and most actual employee salaries in the Northern Lab were below market
- Forensic Scientist Trainee starting salaries at all locations were below the average market minimum salary, HOWEVER
- Forensic Examiner-type salaries statewide (excluding Northern) are in line with average market salaries
- Evidence Receiving salaries statewide were below market
  - Salary adjustments were made within current resource allocations to help increase staff retention
- Other changes will need to be funded through the budget process
